INTENDED USE

EEBD is a short duration, oxygen breathing device, which is intended for a single emergency use, in areas of:

- smoke
- toxic contamination
- oxygen deficiency
- Potentially explosive atmospheres

EEBD is available in the following options;

- Marine 15 EEBD Orange Case
- Industrial 20 EEBD Orange Case

The units described have been designed and tested in accordance with EN 13794:2002, and ISO 23269-1:2008 where applicable, to demonstrate compliance with the essential safety requirements of the PERSONAL PROTECTIVE EQUIPMENT REGULATION (EU) 2016/425 and PPE Regulation (EU) 2016/425 as brought into UK Law and amended. The EEBD also meets the International Convention For The Safety Of Life At Sea, SOLAS 1974 for Emergency Escape Breathing Devices and DIRECTIVE 2014/90/EU MARINE **EQUIPMENT** and Merchant Shipping (Marine Equipment) Regulations SI 2016/1025, as amended by SI 2019/470 & MSN 1874 Amend 4.

PRECAUTIONS

- Due to the potential fire risk it is important to prevent the ingress of flammable substances such as petrol, grease or solvents into the device before and during operation.
- If the device is damaged there is a risk that flammable substances may be ignited if they come into contact with the oxygen producing chemical.
- Do not remove the device from the case until the equipment is required for use. Doing so may reduce the protection afforded by the device.



PRIOR TO USE & INSPECTION CHECKS

Check case to ensure:

- The case is not damaged.
- The anti-tamper label and seal are still intact.
- The unit is within the expiry date.
- The moisture indicator is blue and not pink in colour.
- The equipment should not be used if these conditions are not met.

OPENING DEVICE

EEBD ORANGE CASE

- 1. Pull on the yellow upper latch lever to remove the case upper lid and
- 2. Remove the EEBD by pulling on the base of the breathing hose. This action automatically activates the oxygen generation into the breathing bag.

DONNING EEBD Marine 15 / Industrial 20

- I. Take a breath.
- 2. Insert the yellow mouthpiece.
- 3. Fit the necks strap over your head and adjust as required.
- Fit the yellow nose clip.
- 5. Exhale into the mouthpiece. Then breath normally.
- If the face shield is required unwrap it and pull it over your head, pull the two cords to tighten the face shield around the neck. If the moisture inside the face shield distorts your vision, press it against your face to clear.
- 7. Make your escape.

NOTE:

- The action of removing the breathing device from the case automatically activates oxygen generation. The red sealing bung and cap are connected inside the case via a black lanyard, if for any reason the bungs stay attached to the device when it has been removed from the case they should be removed from the device manually before donning starts.
- The correct positioning of the mouthpiece and noseclip is essential to prevent ingress of atmospheric contaminants.
- Always follow training procedures.

USE

IMPORTANT NOTES FOR USERS

- Immediately the device is donned and a seal obtained activities should commence in a calm manner. Do not rush.
- Maintain a steady work rate to ensure regular breathing. Rapid breathing uses more oxygen.
- During use the starter and oxygen generators will increase in temperature and the air provided by this device will be warm and dry and slight odours or tastes may be detected. These are normal conditions and indicate the device is functioning correctly.



AFTER USE

- Remove the EEBD immediately in a safe area.
- The device can be returned to Semmco LPS Ltd for disposal or rework, see section on 'RETURN CONDITIONS'.

STORAGE AND USAGE CONDITIONS

The device can be stored for up to 15 years. Official regulations on inspection must be observed. The following visual checks must be carried out on a regular basis.

- The case is not damaged.
- The anti-tamper label and seal are still intact.
- The unit is within the expiry date.
- The moisture indicator is blue and not pink in colour.
- If these conditions are not met the unit should not be used and should be replaced with a new unit

RETURN CONDITIONS

The protective device contains potassium superoxide (K02) therefore transportation hazard regulations apply when in transport. The devices can only be transported by road, rail or air cargo and should be returned in their original transportation packaging and marked with the appropriate hazard identification label. When returning damaged or used devices they must be sealed in a plastic bag prior to placing in the transportation packaging.


